Encore Dance Center offers an optional performance in February. It is open to our current students who wish to participate, ages 5 and up. Dancers will take an extra class for three weeks, where they will learn a separate dance that they will perform onstage. Dancers must be able to attend all three rehearsal classes, since each practice is crucial for looking their best onstage. Dancers will be broken up into groups based solely on age and dancers perform a universal dance, meaning that the dance steps taught are commonly found in ballet, jazz, and hip hop.

Each dancer who chooses to perform will be assessed a performance fee of \$50 if paid before January 25th. After January 25th the performance fee will be \$55 to cover expedited fees for the T-shirts. The performance fee covers the cost of rehearsals and the T-shirt the dancers will wear onstage. Dancers will need to provide their own black jazz pants and ballet or jazz shoes. Tickets for the show will be \$5 each, and ticket costs will be used to cover the cost of the theater.

Any students interested in performing must turn in a performance consent form in order to register for the performance. As you register for the performance, tickets are available for purchase. As with our Spring Concert, seats are assigned and tickets will be filled in the order received. If you do not know how many tickets you will need, you may order tickets later as well.
